Cookie Policy



This policy explains how Onwelo Spółka z o.o. ("Onwelo") uses cookies and other similar technologies on our official website: www.onwelo.com.

WHAT ARE COOKIES?

A cookie is a short text file sent to your desktop or mobile browser by a website when you view it.

Cookies contain information about the time they were saved on the end device, the domain name, and a unique number (cookie ID) that identifies the browser from which you connect to the website. Cookies allow websites to remember data related to your visit and may provide information such as your geographical location, the way you have reached the site, how much time you have spent on its different subpages, and the type of device you use (desktop/mobile, operating system).

WHAT COOKIES DO WE USE AND FOR WHAT PURPOSE?

We use cookies to ensure that our site works properly, track the way you use it, enhance its features, boost user experience, and better adapt the site to your interests.

We rely on the following cookie categories:

- * **essential cookies:** these cookies are necessary; they enable you to move around the website and use its features, e.g. by displaying the appropriate version depending on your device. These cookies will be saved and used even if you otherwise reject cookies.
- **preference cookies:** these cookies allow us to match our website to what our users want and need, e.g. to remember their preferred region or language. These data are only stored for a short period of time and have a very limited use. Preference cookies are also completely anonymous. We do not use them for any other purpose. They are only used if you give your consent in the pop-up cookie banner.
- * statistic/analytics cookies: these cookies collect data on how you use our site, e.g. data about your most frequently visited pages, so we can make sure the content we show you is relevant to you, find out what users are interested in and how the website can be enhanced. We also employ tracking pixels to count website visits and performance cookies to check how many unique users visit our website and how often. This information is only used for statistical purposes. Statistic/analytics cookies are only used if you give your consent in the pop-up cookie banner.
- * marketing/tracking cookies: these cookies help us deliver ads that better match your needs, both on our own site and on external sites, in accordance with your selected services and preferences. They also help measure the performance of advertising campaigns. They remember that you have previously visited our website and may share this data with third parties, such as advertisers. Marketing/tracking cookies are only used if you give your consent in the pop-up cookie banner.

We use both our own cookies, which are created and controlled by Onwelo and can only be read by our website, and third-party cookies, which are stored by external providers or organizations.

HOW LONG WILL COOKIES BE USED?

Depending on the time they are installed in the browser, cookies can also be divided into the following categories:

- * session cookies these cookies remain on your device only until your leave the website or close the browser window,
- **persistent cookies** these cookies are not automatically deleted when you close the browser window, but remain on your device until they expire or you erase them manually.

Our website uses both types.

HOW CAN YOU CONTROL COOKIES?

As essential cookies are necessary for you to be able to browse the website, we use them without your prior consent. However, all other cookie types are only installed if you give your explicit consent in the pop-up cookie banner on our website: we will ask you to accept or reject cookies on each visit.

You can withdraw your consent at any time, e.g. by deleting cookies from your browser (to do so, just clear your browsing history) and blocking their future installation. Depending on your browser, the way to delete or reject cookies may vary. To find more information and detailed instructions on how to manage cookies, check your browser's privacy and cookie settings.

However, before you decide to reject cookies or change your browser settings, remember that these files are meant to improve your user experience. They allow us to show you ads that are more relevant to your interests. Disabling cookies may also affect how our website is displayed in your browser.
